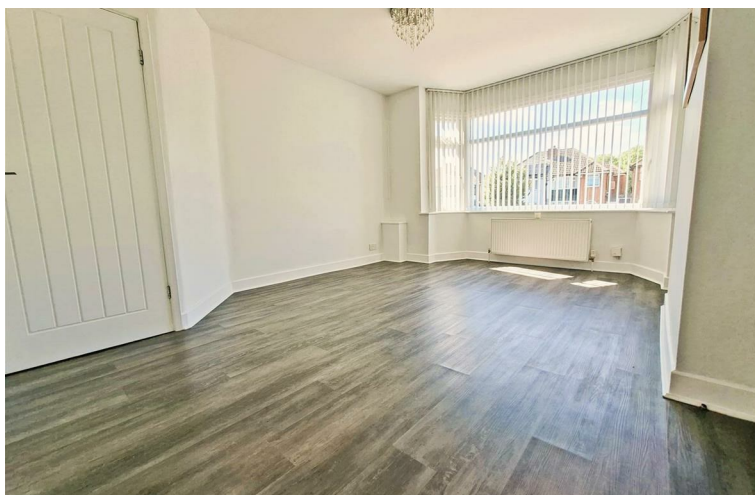
A renovated and extended semi detached house on a popular road in Sheldon with NO ONWARD CHAIN.

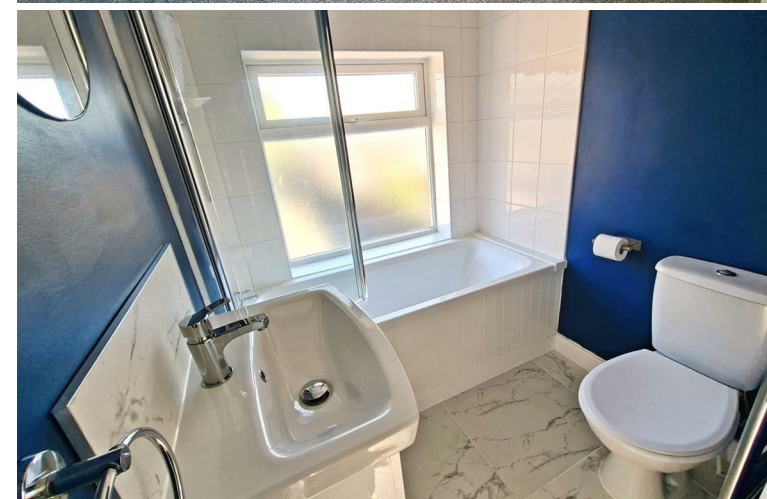

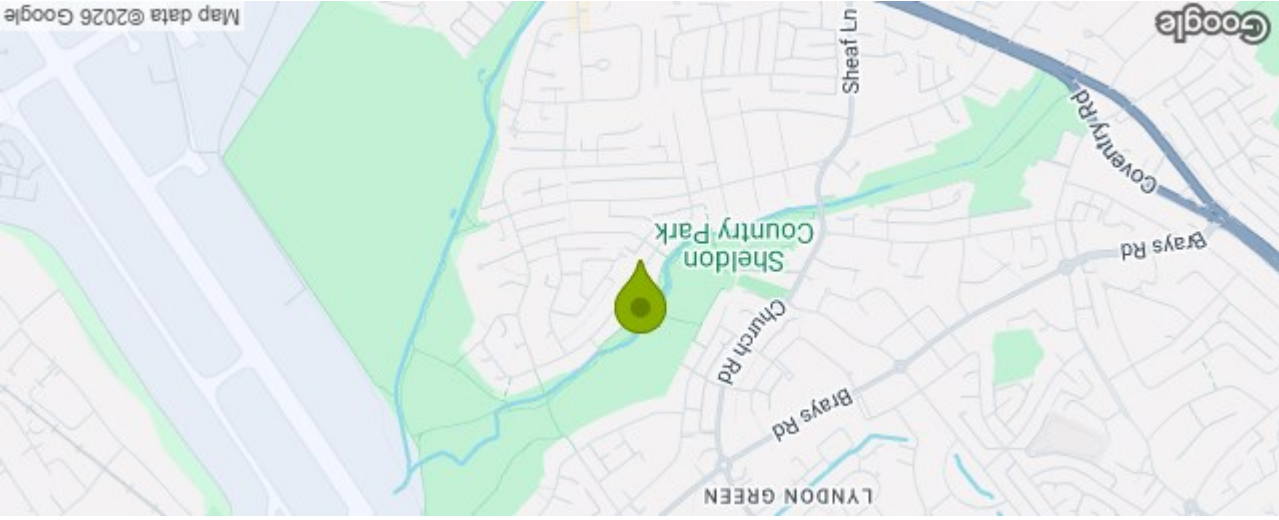
