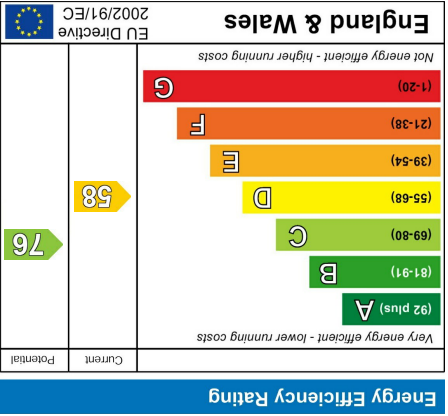


Second Floor
