Approx. 42.6 sq. metres (458.0 sq. feet)

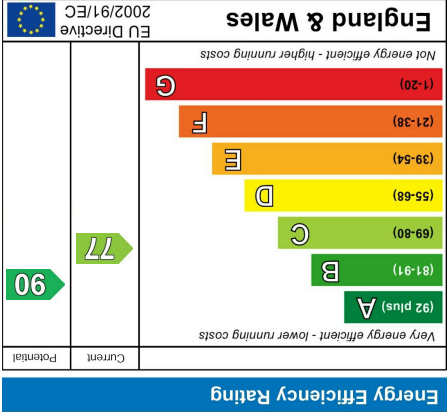


First Floor
