Description

Valley Road leads off Old Lode Lane close to local shops. Old Lode Lane joins Lode Lane, one of the main arterial road giving access to the town centre of Solihull. Travelling away from Solihull, via Hobs Moat Road, one will come to the A45 Coventry Road at the Wheatsheaf where one will find a wide choice of shopping facilities with further shopping in Hobs Moat Road together with Solihull Ice Rink behind which is a local library and doctors surgery.

The A45 gives access to the city centre of Birmingham and in the opposite direction passing Hatchford Brook golf course to the National Exhibition Centre, Resorts World, Motorcycle Museum, Birmingham International Airport and Railway Station and junction 6 of the M42 motorway.

This 1930's semi-detached property is set back from the road behind a driveway leading to the UPVC front door allowing access into the accommodation which comprises of, entrance porch, entrance hall with under stair storage and access into the through living dining room with bay window and French doors opening onto the rear garden, fitted kitchen with a range of integrated appliances, converted garage making an ideal utility space or an extra reception room with access into the front garage storage area.

To the first floor we have three bedrooms two of which are great sized doubles one of which has a large bank of fitted wardrobes. The family bathroom has been extended and offers a 3 piece suite with ample storage options.

To the rear we have a good sized private garden with front and rear patio, garden shed and bordered by panelled fencing. To the front we have ample off road parking on a smart block paved driveway.
