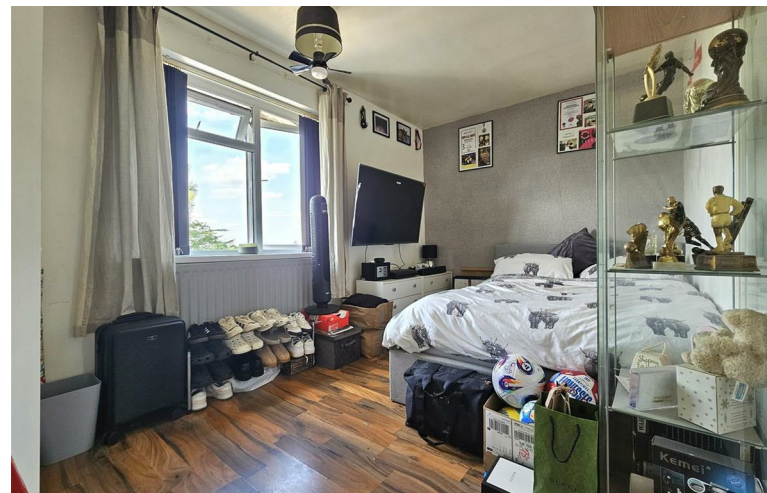
Hobs Meadow links Moordown Avenue and Hobs Moat Road one of the main road through Solihull where one will find an abundance of shopping facilities and along which regular bus services operate to the city centre of Birmingham and surrounding suburbs. Travelling away from Birmingham along the A45 one will come to the National Exhibition Centre, Resorts World, Motorcycle Museum, Birmingham International Airport and Railway Station and junction 6 of the M42 motorway. Hobs Moat Road Leads to Lode Lane, An arterial Road into Solihull Town Centre.

There is a good selection of shops in Hobs Moat Road together with Solihull Ice Rink, a choice of restaurants and takeaway outlets, behind which is a local library, doctors surgery and fitness centre.

This three/four bedroomed mid terraced property holds an excellent position with green views over open space to the front and within walking distance to local amenities and schools. The property is approached via a double width drive way leading to the accommodation which is accessed via a upvc glazed door and comprises of, entrance hall, living room with fire place and access into a rear reception room currently set up as a bedroom. Off the hallways is the fitted kitchen with a range of integrated appliances as well as a door opening onto the rear garden.

To the first floor we have three bedrooms, two of which are great sized double with the third being a large single or tight double. Off the landing is the family shower room as well as loft access.

To the rear we have a good sized private garden backing onto the junior school. With an elevated patio and a good laid to lawn and with the benefit of various brick build out building and a metal shed.
