Description

Valley Road leads off Old Lode Lane close to local shops. Old Lode Lane joins Lode Lane, one of the main arterial road giving access to the town centre of Solihull. Travelling away from Solihull, via Hobs Moat Road, one will come to the A45 Coventry Road at the Wheatsheaf where one will find a wide choice of shopping facilities with further shopping in Hobs Moat Road together with Solihull Ice Rink behind which is a local library and doctors surgery.

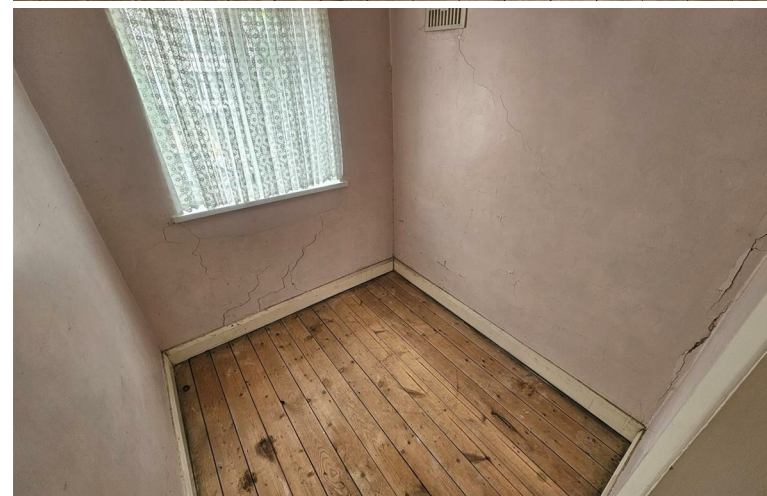
The A45 gives access to the city centre of Birmingham and in the opposite direction passing Hatchford Brook golf course to the National Exhibition Centre, Resorts World, Motorcycle Museum, Birmingham International Airport and Railway Station and junction 6 of the M42 motorway.

This chain free 1950's semi-detached property is set back from the road behind a driveway leading to the UPVC front door.

The accommodation comprises of entrance porch allowing access into all ground floor rooms the first of which is a front reception with bay window fire place. Rear reception with fire place and a glazed rear door opening onto the patio, kitchen with basic fitments and a further door opening onto the side garage. A good sized garage that is ripe for conversion. There is also a rear door of the garage into the garden.

To the first floor we have three bedrooms two of which are great sized doubles complemented by a further single and the family bathroom with a three piece suit with shower over bath and airing cupboard.

To the rear we have a particularly generous garden split into two zones. With a patio area, main garden laid to lawn with panelled fencing and a secondary garden which is a little wild. Ideal for extensions (STPP) or a blank canvas to make your own.

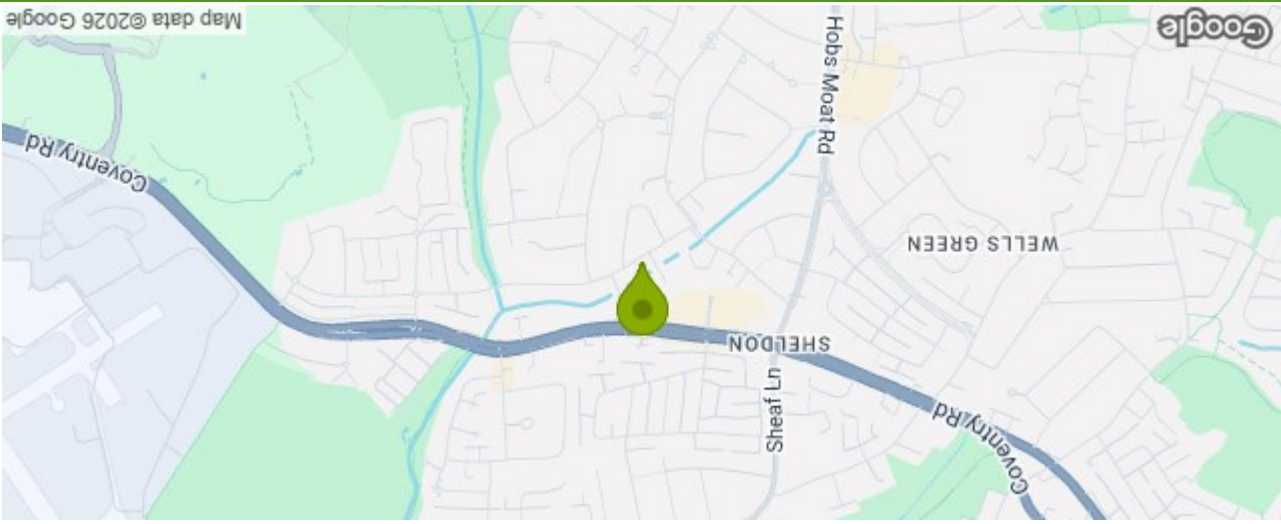

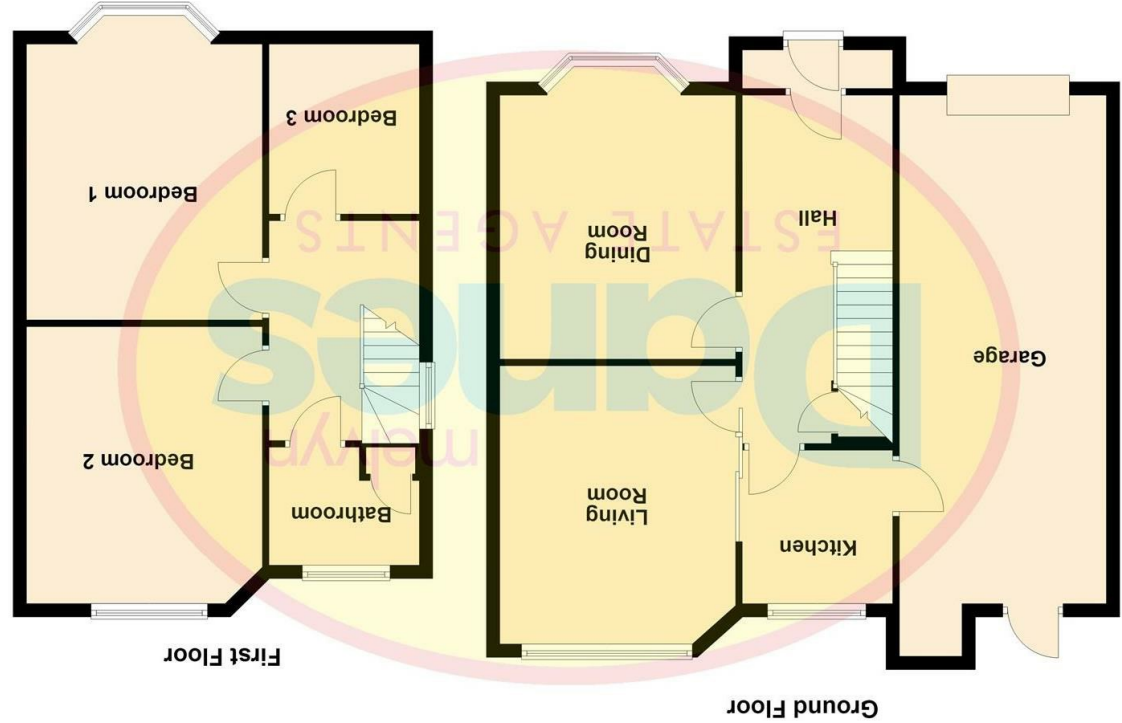
