Description

Gilliver Road is situated on the Shirley Park Estate which links between Bills Lane and Hurdis Road. There is an entrance to the park opposite this property on Grenville Road and also on Hurdis Road where one can walk through directly into Shirley town centre.

The property is situated within the catchment area of nearby Light Hall School in Hathaway Road. Infant and Junior Schooling is catered for at St James Tudor Grange Academy which is a feeder school for the much requested Tudor Grange Secondary School. Also nearby, on the main Stratford Road, you will find Our Lady of the Wayside Roman Catholic Junior and Infant School and in Solihull on Whitefields Road is St Peter's Roman Catholic Senior School, although all education facilities are subject to confirmation from the Education Department.

The main shopping centre in Shirley offers a wide choice of Supermarkets, convenience and speciality stores, restaurants and hosteleries and there are frequent bus services running along the A34 into Birmingham City Centre and Solihull Town Centre – boasting the vibrant and modern Touchwood Centre offering shopping facilities and evening entertainments. Shirley has its own train station in Haslucks Green Road, providing a train service to Birmingham City Centre and Stratford upon Avon.

Off the main Stratford Road leads Marshall Lake Road boasting the Retail Park and further down the A34 one will find the Cranmore, Widney, Monkspath and Solihull Business Parks and on to Blythe Valley Business Park which can be found at the junction with the M42 motorway, providing access to the Midland Motorway Network. A short drive down the M42 to Junction Six, you will find Birmingham International Airport and Rail Station.

An excellent location therefore for this end terrace house which sits back from the road behind a front driveway with EV charger. The property is nicely presented throughout and has accommodation comprising in brief of hallway, lounge, kitchen and dining room on the ground floor. To the first floor are three bedrooms and family bathroom and stairs rising to the loft space. The well maintained family home also benefits from having a useable loft space and in the rear garden has a utility space, wc and store.
