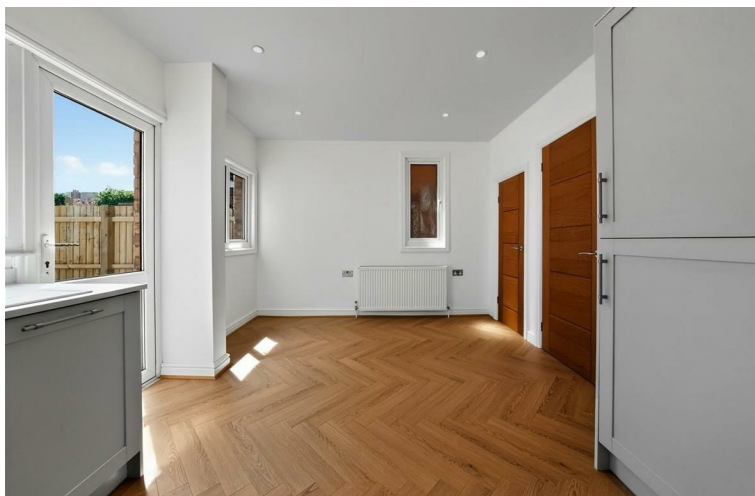
Description

Sandy Hill Road is a popular residential road leading from the main Stratford Road in Shirley. Along the main road run regular bus services into the City of Birmingham and nearby central Solihull, where there are excellent shopping and business facilities.

Festooned along the Stratford Road are an excellent range of shops, including a wide choice of Supermarkets and Superstores on the nearby Retail Park. A thriving business community exists along the Stratford Road and this extends down to the Cranmore, Widney, Monkspath and Solihull Business Parks, and beyond here a journey of some three miles from the property, to the M42 motorway, forming the hub of the Midlands motorway network.

Schooling in Shirley is of considerable renown. An excellent location therefore for this traditional semi detached which has been the subject of a comprehensive refurbishment by the current owners to include a replacement roof covering, re-wiring, new central heating system and a total internal redecoration with a beautiful fully integrated kitchen diner and replacement bathroom.
