## Description

This greatly extended traditional semi detached property occupies a prominent cul-de-sac position near the end of Jacey Road close to Palmers Rough. Conveniently located a short walk away from the amenities of the town centre of Shirley. Nearby Ralph Road hosts Streetsbrook Infant School with primary and secondary schooling being catered for at Langley Schools in St Bernards Road and Kinton Green Road respectively. There is also Our Lady of the Wayside Roman Catholic School on the nearby Stratford Road in Shirley. Education facilities are subject to confirmation from the Education Department.

On the main Stratford Road one will find an excellent array of shopping facilities ranging from small speciality and convenience stores to a choice of major supermarkets and Superstores on the Retail Park, access to Shirley Park; a very pleasant area of public open space and easy access to regular bus services to the nearby town centre of Solihull or the City of Birmingham and its outlying suburbs. Approximately one mile down Haslucks Green Road will bring you to Shirley Railway Station which has regular commuter services between Birmingham and Stratford upon Avon.

There is a wide choice of restaurants and hostelryes along the Stratford Road and a thriving business community which extends to the Cranmore, Widney, Monkspath and Solihull Business Parks. A journey of approximately three miles from the property will bring you to the M42 motorway which forms the hub of the national motorway network.

An ideal location therefore for this excellent semi detached house which has been considerably extended over the years to maximise the width in the plot. The accommodation has been well maintained by the current owner and is ready in part for some cosmetic updating; which would be a great project for some buyers who simply want to make a home their own without the need for costly extensions. Viewing really is recommended to appreciate the accommodation on offer.

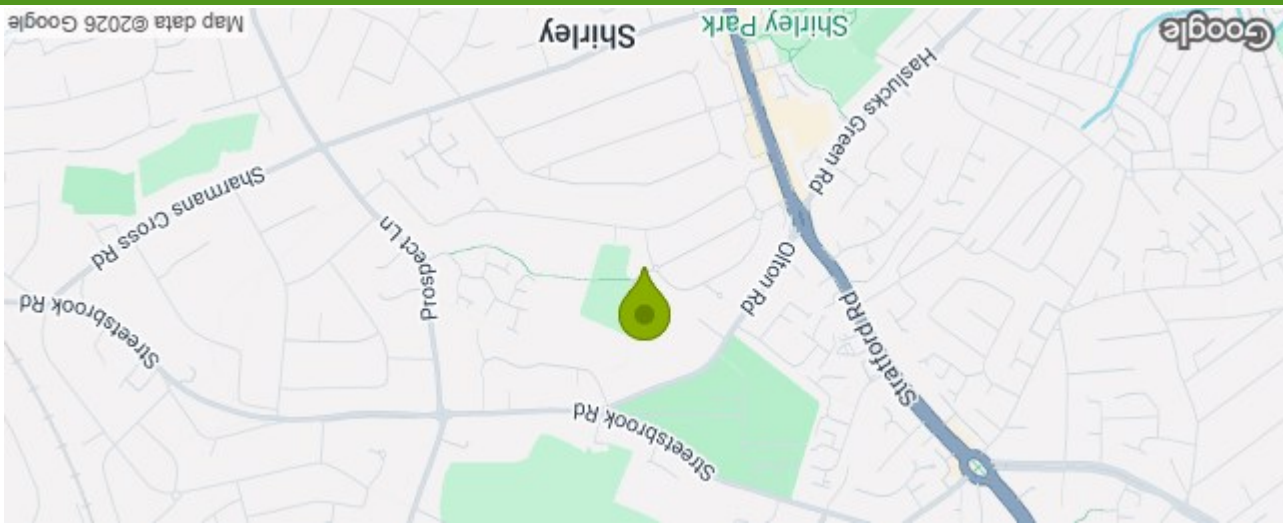
