Description

Originally built by Taylor Wimpey, this first floor apartment benefits from an independent front door and private staircase and is situated in this two storey quad block overlooking a small green area on the fringe of this convenient development. The property has as an allocated parking and communal gardens for the use of the four apartments.

Conveniently situated in this small development just outside Shirley Town Centre which offers a wide choice of Supermarkets, convenience and speciality stores, restaurants and hostelryes and there are frequent bus services running along the A34 into Birmingham City Centre and Solihull Town Centre – boasting the vibrant and modern Touchwood Centre offering shopping facilities and evening entertainments. Shirley has its own railway station providing a train service to Birmingham City Centre and Stratford upon Avon.

Off the main Stratford Road leads Marshall Lake Road boasting the Retail Park and further down the A34 one will find the Cranmore, Widney, Monkspath and Solihull Business Parks, and on to Blythe Valley Business Park which can be found at the junction with the M42 motorway, providing access to the Midland Motorway Network. A short drive down the M42 to Junction Six, you will find Birmingham International Airport and Rail Station

Sitting back from the roadside at the rear of the block with independent front door the accommodation really does need to be viewed to be appreciated.

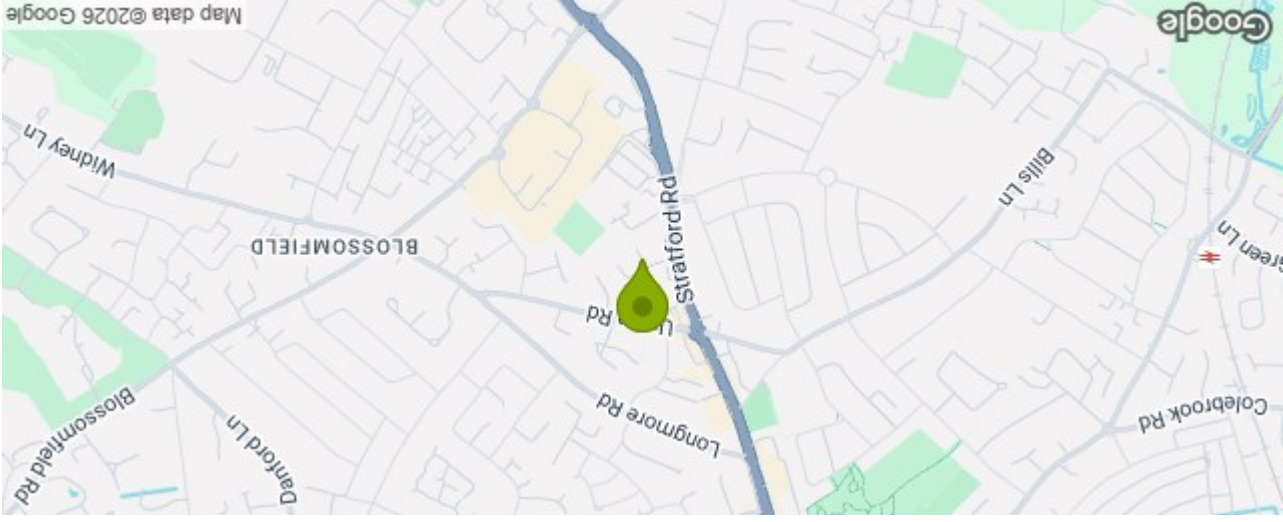

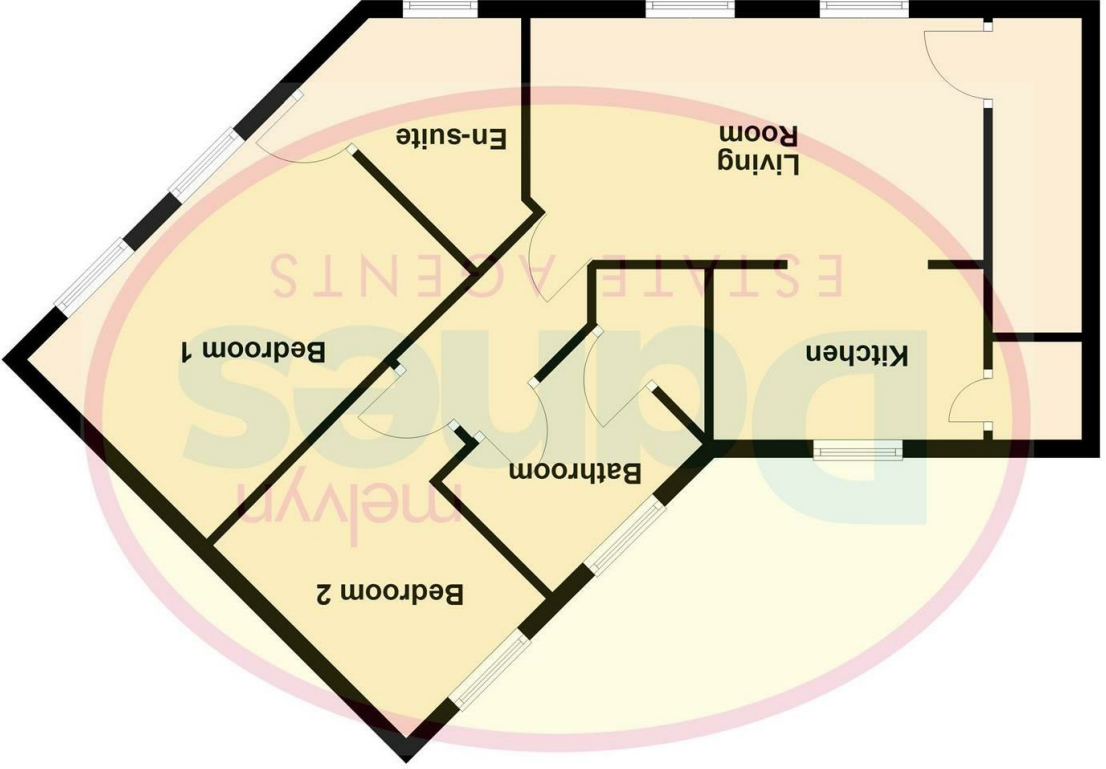
