A short drive down the M42 to Junction Six, you will find Birmingham International Airport and Rail Station.

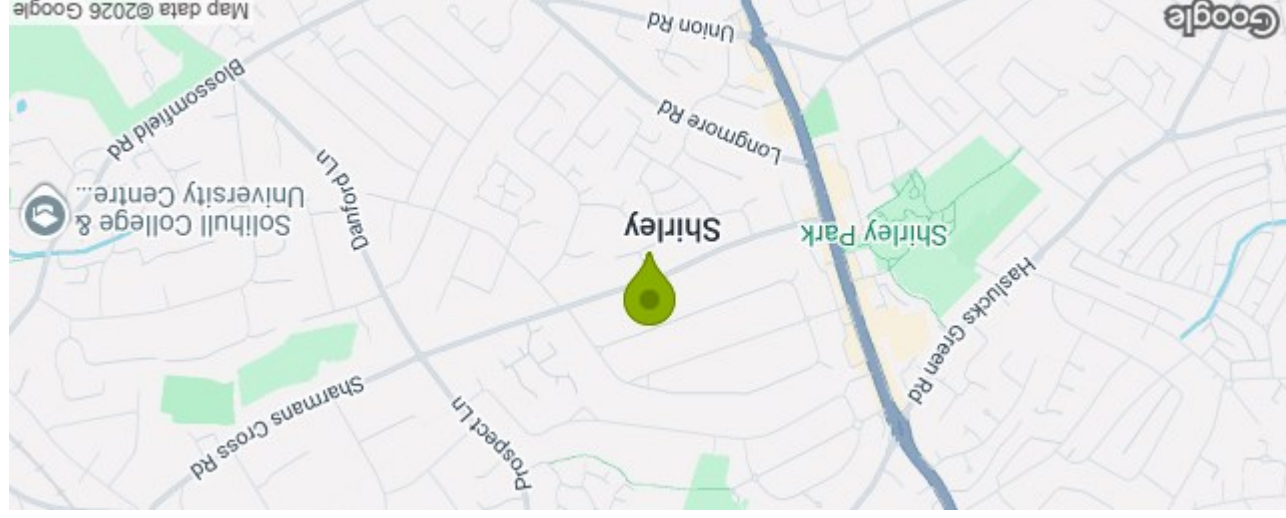

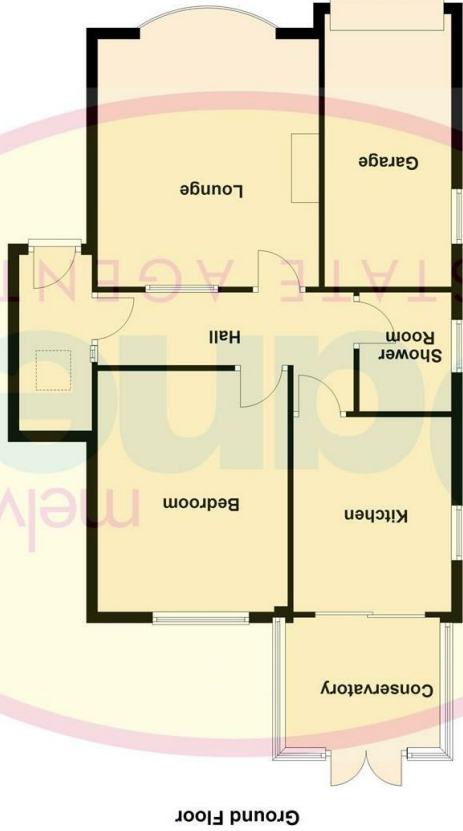
