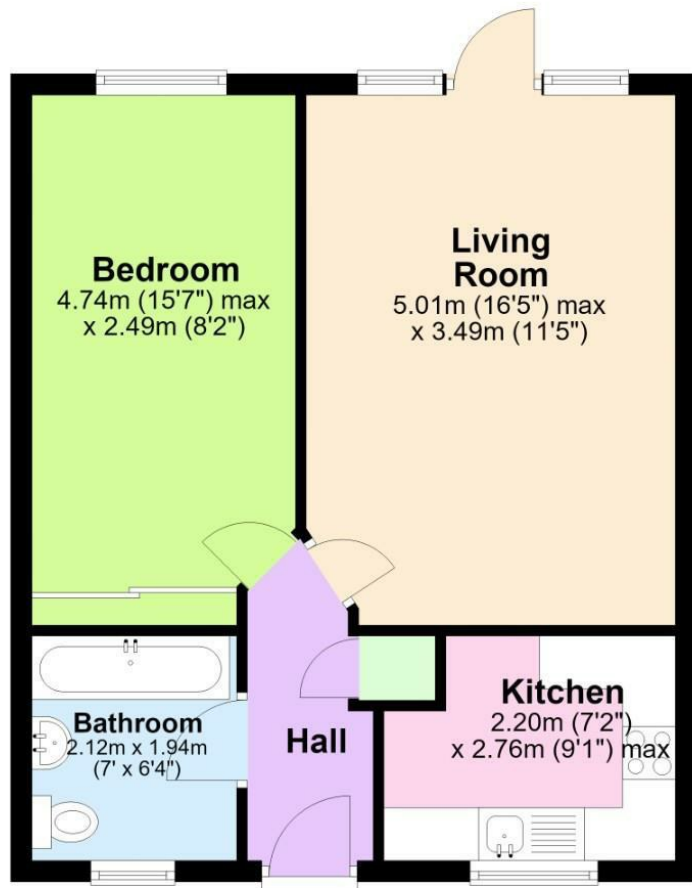
Within the development there is resident parking located close to the property and communal garden areas. To the rear of the property there is a patio and further more communal lawn area perfect for summer seating and relaxation.
