The pretty elevations include ragstone, brick, tile hanging and some timber cladding under a tiled roof.

The cottage was enlarged a number of years ago with the conversion of the original garaging to create the inner hall, shower/utility room and the study/bedroom three.

The well maintained accommodation is arranged over two floors with entrance and inner halls, a sitting room, dining/kitchen, study/bedroom three and a shower/utility room to the ground floor, and a landing, two bedrooms and bathroom to the first floor.

There is a parking space to the front, front and rear gardens with the rear garden adjoining open fields.
