To the rear of the property is communal gardens and a private car park for residents only.

Terrain Map



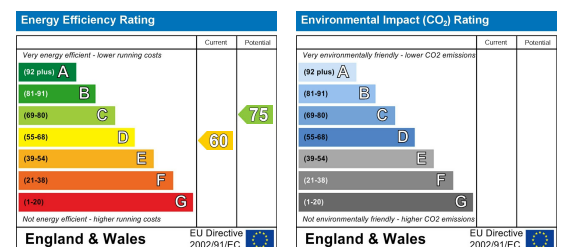
Floor Plan
