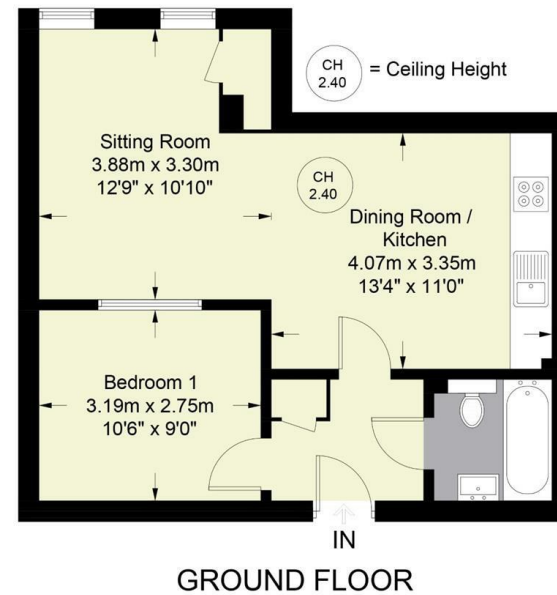






Tempus Court, Bellfield Road
