

**FIRST RECEPTION 14'1 x 12'**

Benefiting from a bay fronted window, radiator, power points, feature fire surround and a door that leads to:

**SECOND RECEPTION 12' x 11'11**

There is a window to the rear aspect, radiator, power points, stairs leading up to the first floor landing, under stairs cupboard and access to:

**KITCHEN 12'9 x 7'2**

Having a range of wall and base units and work surfaces, sink with a mixer tap, integral oven, hob with extractor, window to the side aspect, power points and a door to the side leading to the yard.

**FIRST FLOOR LANDING**

With access to the loft and doors that lead to:

Regular bus services run into Leicester where there is a Main Line railway station. Trains to London (St. Pancras) take from one hour and the East Midlands International Airport is approximately 25 minutes drive away, traffic allowing.

Anstey is a Leicestershire village on the edge of the renowned Charnwood and National Forests with their many scenic country walks and golf courses. The village is situated north-west of Leicester's City centre which is just four miles away. Anstey still retains some of the charm of a traditional village but with easy access to major road routes. The village has a variety of different shops and services making it the commercial centre for surrounding smaller villages. A supermarket is close by and a number of independent, family run businesses including our office can be found as well as Post Office, Vets, restaurants and a couple of fast-food outlets. 
